Subject: Implementation of value added Tax (VAT) in UAE – TAX registration Number and Invoicing

This is in reference to the implementation made by the UAE Government to introduce VAT in the United Arab Emirates from 1st January 2018, In accordance with the UAE Federal Decree Law (8) of 2017 at a Standard rate notified by UAE Federal Law.

In order to ensure compliance with the law and to process any invoices we will require certain information from you as listed below

1. Copy of your VAT registration certificate or proof that in compliance with law you do not require to be VAT registered in the UAE.
2. On submission of any invoices for payment, the invoice must be accurate and compliant with the VAT law (please note that invoices not accurate and/or in compliance with the VAT law cannot be paid).

Attached is a copy of our Tax Registration Certificate with **TRN** (Tax Registration Number) **100071572000003**. We would kindly request you to share with us your Tax Registration Certificate as soon as possible, to allow us to have accurate records and minimize the risk of non – payment due to non-compliance.

From 1st of January 2018 your invoices will need to be VAT compliant and accurate i.e. addressed to the correct legal entity.
