ANNEX 1 – TERMS AND CONDITIONS

- 1. ENTIRE AGREEMENT: These terms and conditions form part of the Purchase Order and no prior or subsequent representations or agreements, whether verbal or in writing, by the Buyer or the Seller or any employee, servant or agent thereof shall bind the Parties.
- 2. SUPPLY: The Goods described in this Purchase Order shall be supplied by the Seller to the Buyer strictly in accordance with the terms set out herein, and no alteration to such terms shall be made thereto without the written consent of the Buyer. Time shall be of the essence of this Purchase Order unless such requirement is waived by the Buyer in writing.
- 3. SELLER'S DEFAULT: If the Seller fails to deliver the Goods to any delivery site nominated by the Buyer by the date and/or dates specified herein, or shall fail to comply with any other condition contained herein, the Buyer may at any time thereafter and without prejudice to any of its other rights refuse to accept the Goods irrespective of whether or not the Goods have been delivered (property in the Goods having not passed to it) and may in its absolute discretion procure similar Goods elsewhere and the Seller irrevocably and unconditionally indemnifies the Buyer from all costs and expenses in its so doing, including the cost of purchasing the said similar Goods and any other costs of any nature incurred by the Buyer as a consequence thereof
- 4.
